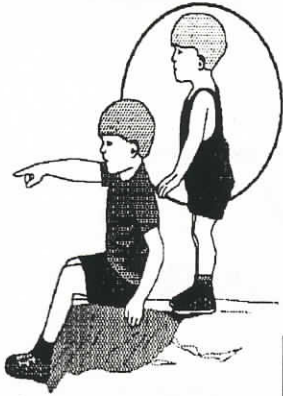
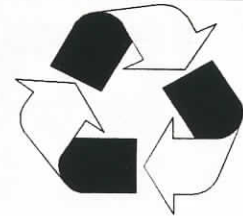

We find ourselves in an ever increasing environment of **specialization** for products and services. This **raises** both personal and corporate **accountability**.

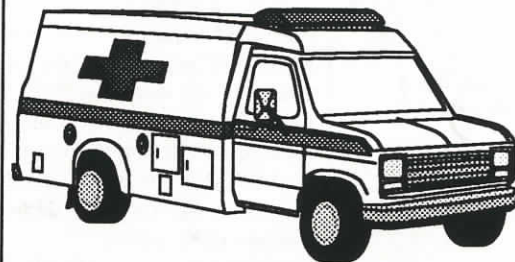
In the building and construction industries there are design and installation specialists in every aspect of a project. This specialization has **raised** the level of responsibility and therefore **liability to the client and user**.
